# Background on OPRS and Tier 1 Support Services

#### 2018 Oct

The Government has regularised On-site Preschool Rehabilitation Services (OPRS) since October 2018. Currently, OPRS is operated by 21 Non-Governmental Organisations (NGOs) at about 900 Kindergartens/ Kindergartens-cum-Child Care Centres (KGs/KG-cum-CCCs).

#### 2020 Aug

The Social Welfare Department (SWD) launched a project namely "the Pilot Project on Tier 1 Support Services in Kindergartens/ Kindergarten-cum-Child Care Centres" (the Tier 1 Support Services) for 37 months to provide early intervention services to children with signs of special needs, children awaiting assessment by Child Assessment Centres (CACs) under the Department of Health (DH), or assessed by CACs to have borderline developmental problems.

#### 2023 Sept

The Government has regularised the Tier 1 Support Services since September 2023 and the services integrated with OPRS to offer comprehensive and timely assistance to pre-school children with different levels of special needs through inter-disciplinary service teams under a school-based and integrated approach.

### Termination of Service

The services under the OPRS will only be provided up to:

- 1st September after the child has attained the age of 6;
- the date when the child is admitted to primary school;
- the date when the child has no more service needs as assessed by the operating NGOs; or
- one day before the child's departure from the participating KG; whichever is earlier.
